1. **APOLOGIES:** *Angus Jm*
2. **Adoption of minutes for meeting of Tuesday 20 January 2009**
Proposed by Mr A Guthrie, Seconded David Broadhead.
3. **POLICE REPORT:** P C Richard Armstrong and P C Stephen Ferry attended the meeting. During the previous month there had been one report of vandalism in Station Road. Also a drugs offence. Reminded everyone to be aware of fraudulent letters and cold calls.
4. **COUNCILLOR'S REPORT:** Mr Storie commented on state of roads and mentioned in particular bad patch at foot of Coal Pit Road and also on Station Road between Croft and newly tarred area.
5. **MATTERS ARISING:**
 - Site for bench.** Secretary contacted Scottish Water Solutions who ask for an estimate to be sent. Mr Findlay has attended to this. Mr Fergusson of S W S advises that the wall to be built at the main site entrance has to be agreed with landowner and will be attended to eventually.
 - Labyrinth:** The area has been marked out and Mr Guthrie is still trying to source some large boulders.
 - LIMEKILN:** Mrs Masterman has found the sign which is in good enough condition but needs a frame or wood surround so that it may be re-erected.
 - TRAFFIC ISLAND:** Mr Findlay commented on the bad positioning of traffic island on Dunure Road near entrance to Belleisle and Mrs Petticrew confirms this is being removed.
 - Lighting Columns:** Mrs Petticrew reported as follows: "A condition of new developments building approval requires the developer to erect a number of new columns along an existing road, where required. While they require complying with regulations there will always be a slight difference in finish". (Secretary points out some of the columns on Doonfoot Road have now been painted and this seems to be ongoing).
 - New bin at bus stop.** Mrs Petticrew suggests the bin be relocated from the shop to the bus stop as the Council does not have funds to supply another bin.
