3. POLICE REPORT: No police report at this date.

4. COUNCILLOR'S REPORT: Councillor Goldie states with so much happening in the political world at the moment, the Council is in a state of flux. The condition of the roads was again discussed and while we could confirm the large pot hole on Arran View had been repaired, the part of Station Road from the Croft to the gate of the Water Treatment Plant is causing Concern as it is gradually disintegrating. Mr Storie also commented on the area at Fisherton Farm where there is a pothole needing repair. As Councillor Goldie has repeatedly pointed out to us the money is just not available for the amount of work needed on South Ayrshire roads.

5. CHAIRMAN'S REPORT:

Mr Montgomerie reported that we were not undertaking any big projects at the moment. We were happy that the Waste Water Treatment Works had been completed and we just need to Get completion on the area where the bench is positioned. The Labyrinth is now nearing completion and thanks to Mr Guthrie for his work here. There has been nothing further in respect of the proposed Wind Farms but this may be on hold as there will shortly be a complete overhaul of the Planning System. Mr Montgomerie thanked all the committee for their excellent attendance at meetings and for their commitment and interest in the community. He also thanked Mr Storie for the excellent administration of our finances, and Mrs McGinn for all her Secretarial work.

- Site for bench. A further estimate has been sent directly to Mr Alan Ferguson, Scottish Water Solutions, for the work involved in reinstating this area. Mrs Petticrew asked why this was not attended to through South Ayrshire Council, but was advised that we have had a good relationship with Scottish Water and at the time we had no Link Officer to advise. She has confirmed, however, that the roads department have no problem with the position of the bench and that S A C will maintain this area so long as it has been made up to a certain standard.
- **Labyrinth:** This is nearing completion as Mr Guthrie should have spent all the grant by the end of May. Comments on this labyrinth have been favourable and should be another point of interest in Kennedy Park.
- Sgt Sandy Douglas will attend the start of our next meeting in June to talk about traffic arrangements for Open Golf Tournament at Turnberry in July.
- Kennedy Park: Mr Guthrie and Mrs Petticrew could confirm that some of the proposed work in the park has been attended to - the small bridge has been repaired and the bollards and fence are being treated. Mr Guthrie has the paint for the Toilets and other work is ongoing.
- **6. FINANCIAL REPORT:** Mr Storie submitted a draft of the Annual Accounts as follows: During the financial year we received £945.45 (Balance of Civic Pride Grant), £3990.00 (Labyrinth Grant) and £434.71 being our Administration Grant from South Ayrshire Council. The Civic Pride Grant has been spent on Bench and installation, carpark mesh, and signs for the speed bumps in car park. At the end of March our account held a balance of £2625.32. the bulk of which is the Awards For All Grant for the Labyrinth.
