3. **MATTERS ARISING:**

Pumping Station, Seaview: *Nothing further to hand here. Dawn McDermott, Scottish Water, indicated there would be a perimeter fence erected at the main treatment works early in the New Year.*

Toilets: *A letter was written to South Ayrshire Council asking for explanation on the decision to close the toilets during the winter. Councillor Alan Murray has been in contact with Stratton McDonald who suggests if the Community Council takes responsibility for the opening and cleaning of the toilets (the disabled toilet only), he will see that we are supplied with soap, toilet rolls etc. As we are agreeable to this the Secretary will telephone and write to Stratton McDonald to make arrangements.*

Pot Holes: *This was discussed at last meeting and still causing problems. Large hole at bottom of Station Road, also on Lagg Brae, which is an area of new surface. The stretch north of the school not resurfaced last year is also breaking up.*

8. ANY OTHER BUSINESS:

- Letter of resignation from Mr Hudson. Will write thanking him for his services to the Community Council.
- Mr Eaglesham concerned about the removal of play equipment from the park, and is of the opinion we are poorly off for a play area compared with other villages. Mr Broadhead has seen the area being measured and assume new equipment will be put in place. Councillor Murray will find out about this but it was agreed South Ayrshire Council should keep Kennedy Hall & Park Committee or Community Council informed of their intentions here.
- The Web Site domain name had to be re-registered hence the bigger payment this year. As more people have now Internet access we should be promoting the Web Site and getting more information across through it.
- A question was raised by a member of the public on digital television reception and it was agreed no signal was available as yet in this area.
- Letter from Mr Rankin re Seaview access was discussed, and Councillor Murray will check planning for all details of this. But owing to length of time this has been in place there is little chance of it being overturned.
- Scottish Water had been renewing water main in Station Road but had suddenly stopped at no 14. Secretary will try and ascertain the position here.
- Wheelie Bins: Mr Eaglesham asks why brown bins are emptied during winter months when not being used.
- Mr Storie commented on roadside litter on A719 Dunure to Ayr and also A77
- Email from Janey McCreath about bushes overhanging Carrick Place passed to Councillor Murray.
