## **Presentation about ReHabGroup:**

Mel Balfour a Development and Support Worker from the Maybole One Stop Shop gave a presentation outlining the various services which the group provides for the Community. This free help includes advice on consumer health issues, trading standards, benefit checks, pension-credit (awareness days), home shopping; together with cheap travel provision by vetted taxis (£3.60 for an adult, £1.60 for under 16's), and a film club called "Over the Rainbow". Leaflets about these services are available.

The scheme is a pilot scheme funded by the Lottery for eighteen months. So far £105,000 of unclaimed benefits had been generated.

She proposed an outreach scheme for Dunure and suggested a flier could be issued to all local residents.

## **Adoption of minutes for meeting of 20 May 2008.**

**POLICE REPORT:** No report was given.

## **COUNCILLOR'S REPORT:**

Councillor Goldie drew our attention to South Ayrshire's provision of a Care and Repair service to provide subsidised services such as plumbing and roof maintenance to the over 60s.

She had raised the matter of vulnerability of certain sections of the Station Road ditch with Blair Wyllie.

The matter of the rock rubble between the new access slip road and Prowrie beach was raised. This barrier is preventing the slip road from being used by both pedestrians and small boats.

The concern about the graffiti on the castle was raised again. It was pointed out that the broken padlock which had been reported to S A C had now been replaced by Mr Andrew Guthrie.

## **MATTERS ARISING:**

- i. The work on the electric cable which was laid to be laid in Harbour View would not affect the Gala. There would be access at all times. Double yellow lines would be painted when the work was completed.
- ii. R Storie gave a report on his trip with Mr Jim McCrindle to photograph the coastal features named by previous fishermen. (Some of the names have Gaelic origins taking them back hundreds of years). Features from the Heads of Ayr to Culzean Bay had been recorded. It was felt that Mr McCrindle should be recompensed for the cost of the fuel.
- iii. Incorrect delivery of mail. The answer to this problem was that the individual concerned should raise the specific complaint with the Postal authorities.

## Matters arising continued.....

- i. The Labyrinth. Mr Guthrie reported that the site had been motivated, that the steps should be finished during the coming week, and that Morrisons Action Earth had promised £25 funding on completion of the project. This was in addition to the £3990 from Awards From All.
- ii. Mrs Masterman reported that the bench had now been ordered. It would cost £400. It would be invoiced on delivery.
- iii. The Speed Bumps in the Park had been installed by Mr Philip Findlay.

### FINANCIAL REPORT:

The sum in the current account was £5362.54. This included the above Awards for All Grant. The Community Centre account stands at £2484.30.

- Energy Awareness. An Advice Surgery taken by Cathy Jamieson MSP in Maybole Town Hall on 27 June.
- Croyburnfoot lodges Appeal to be held in county Buildings on 24 June at 10am.
- Road problems. A letter has been received by Archie Monkhouse following the Joint Community Council's meeting with the Roads Department.
- Planning Applications - there were no current applications.

### ANY OTHER BUSINESS:

- There were still no yellow lines in the bus park.
- It was felt that in the absence of our other councillors that they should be lettered to keep them informed about any relevant developments or problems. Do they get copies of our minutes?
