2. **ADOPTION OF PREVIOUS MINUTES:** Proposed Mr A Guthrie

3. **MATTERS ARISING:**

**Pumping Station, Seaview:** Dawn McDermott, Scottish Water, has passed on the following information: Planning Department asked them various questions in relation to the Seaview Site to which Scottish Water have now replied. Still awaiting site visit and "pegging out" of area.

Everything is in order for main site in croft field and a fence will be erected and preparation for access commenced.

Road will only be completely closed as and when necessary on instruction from Highways Department and Police.

Start date will be in May at earliest.

Scottish Water will accommodate village for Gala Day and we must confirm date to them as soon as known. Would be able to erect signs indicating access to park and all facilities available if not via Station Road, then access from south.

**Pot Holes:** Some have been repaired but Mr Storie suggests there is a problem with the product used as some of the repaired holes are beginning to break up once again. The pavement in Carrick Place is being resurfaced.

**Seaview Access:** There has been a further letter from Mr Rankin. We feel that as this has been discussed at great length and various suggestions made, we have exhausted all avenues within our jurisdiction, and are in agreement we write to Mr Rankin suggesting he takes the matter up with Councillor Murray and/or his M P.

**Windfarm at Knoweside:** It was agreed that Mr Storie's letter to planning should be on his behalf only, and a modified version expressing our concern over road safety at Electric Brae be sent to Neil Feggans.

**Pavement:** at Carrick Place – resurfacing not completed – Cllr Murray will query this.

**Energy Agency:** It was agreed to contact them to come possibly to an open evening or an afternoon drop-in, to discuss ways to improve energy efficiency and be advised on grants available.

4. **POLICE REPORT:** P C John Hamil sends his apologies and reports no crimes in the area during the last month. Asks that everyone be alert as there have been thefts of quad bikes and plant in the area. He will contact Jim McCrindle to make all harbour users security conscious.

5. **COUNCILLOR'S REPORT:** Councillor Murray will write again re shrubs to be cut back. Mr Broadhead asked if Councillor Murray could find out why play equipment has not been completely installed in park. Work has been commenced then stopped and it is hoped this will be done by Easter.

Fisherton School has requested a blue bin in order that they may re-cycle. Councillor Murray and Chief Executive of South Ayrshire Council will be visiting village to look at facilities. Fisherton School will be visited and also Hall.

Councillor Murray has written re "keep access clear," sign at park but as yet no reply.
