## **APOLOGIES:**

- 2. Adoption of minutes for meeting of Tuesday 19 May 2009**  
Proposed by Mr A Guthrie, Seconded Mr Roy Storie.

*Before the meeting commenced, Sergeant Sandy Douglas spoke about the traffic arrangements which would be in place during the week of the Open Golf Tournament at Turnberry. It is expected there will be between 8000 and 9000 cars using the road. The A77 and the Maybole High road would take the bulk of the traffic, but while the A719 would not be used as a recognised route to Turnberry there would be an increase in traffic on this road especially with local residents wanting to avoid the heavy traffic on the main roads. Mr Montgomerie thanked Sgt Douglas for his information.*

**3. POLICE REPORT:** There have been 14 reported incidents in the last month - cattle on the road, theft of a motor vehicle, some vandalism, a rubbish fire at Carrick Place which damaged BT lines. There were also three public disorder incidents, one domestic and boy racers on A719. There were no arrests.

**4. COUNCILLOR'S REPORT:** Councillor Goldie confirms there will be more changes within the Council. Public will have more information and there will be more public meetings. She states the Civic Theatre is costing the Council money just to be there and would cost a lot more to demolish. Gaiety is more in the red than previously thought.

## **MATTERS ARISING:**

- **Site for bench.** We still await a cheque from Scottish Water to have this area completed.
- **Labyrinth: Children** from Fisherton School helped on two days to spread gravel on the labyrinth - which they thoroughly enjoyed, and at the same time moved about two tons of material. Mr Guthrie hopes to have an official opening on a date to be decided.
- **Planning Meeting Maybole** was attended by Mr Findlay and Mrs McGinn who found it very informative. Forms were distributed for anyone interested in joining the Planning Forum.
- **Constitution:** A form has been completed agreeing to proposed changes.

- **Sign at Limekiln.** Owner of house and limekiln annoyed that he was not consulted about the erection of sign. Mr Guthrie explained this had been there for a number of years and had fallen down and we just wanted to re-erect. He will speak to him again about this.
- **Wall at Kennedy Park.** This was damaged not by a bus as we first understood but by a breakdown truck removing the bus. Mrs Guthrie saw it happening but did not get the registration number. Community Police suggests she reports this to police as driver should not have left the scene without reporting this himself. Mrs Petticrew will try and contact the towing company.

## **6. FINANCIAL REPORT:**

**At 11 June the balance in our Administration Account amounted to £1267.16 (An amount of £550 has been paid for fencing for the Labyrinth access).**

**Community Hall Account amounts to £2491.38**

**7. OPEN FORUM:** This took place prior to Councillor's Report and Matters Arising. As the subject was concerned with Planning, Councillor Goldie declared interest and had to withdraw. The residents surrounding Balig Farm expressed great concern about a planning application by the owner Mr Mark White. This consists of a strip caravan site of approximately 142 Static/touring caravans and tents. This is proposed to be along the A719 opposite Craig Tara and will stretch for about ¾ mile. Community councils members are in agreement that we will write and object in the strongest possible terms. Everyone is of the opinion that this would be detrimental to the area as we have many caravan sites along this road, and no-one could see any benefits either in employment or cash injection to the area.
