1. **APOLOGIES:** P C John Hamil, Councillor Ann Galbraith, Mr John Eaglesham, Mr P Findlay.
2. **Adoption of minutes for meeting of 18 March 2008.**
Proposed by Mr A Macleod, Seconded Mr Roy Storie.
3. **POLICE REPORT:** P C Hamil gave his apologies. During March/April three persons were reported for driving offences.
4. **COUNCILLOR'S REPORT:** Councillor Goldie was pleased to confirm the toilets at Dunure are not included in the rationalisation programme and will be open at least during the summer. She also reported that the walking distance to school will not affect Fisherton, and the status quo will be maintained as far as transport goes. Councillor Goldie was advised that the 30mph sign on Ayr Road had been repaired, and that the flashing lights north of the school are now operating. Mrs Masterman pointed out that Scottish Water had mentioned surfacing the entrance to the Dunure Inn Car Park as there would be increased local traffic due to work on the Pumping Station. Councillor Goldie will contact Dawn McDermott to find out about this.
5. **MATTERS ARISING:**
 - a. **Civic Pride:** The funding has been received for the balance of the bench, installation of same, also for some "enviroscape" for Kennedy Park. Once the cheques have cleared these items will be ordered.
 - b. **Pumping Station:** There is concern that this seems much higher than it was anticipated. Mr Montgomerie will contact GMJV and speak with them about this.
 - c. **Labyrinth:** Mr Guthrie is hoping to receive funding before long. How much money received will determine how this labyrinth is constructed.
 - d. There is concern about the road opposite Water Treatment Works as the verge is being eroded and there is now quite a ditch. This seems to have been caused by vehicles turning into Treatment works. Secretary will contact Scottish Water for their comments.
