

# DUNURE COMMUNITY COUNCIL

MEETING ON TUESDAY 20 November 2007  
IN KENNEDY HALL, DUNURE, AT 7.30PM

Representatives from Scottish Water and GMJV (contractors for Waste Water Treatment Project) attended our meeting and gave us information on the timescale and possible disruption during construction of the Pumping Station at Seaview. This work is due to commence in January 2008 and they hope to have this completed by Easter. They propose to have Harbour View closed part of the time due to excavation work, but it was put to them that access would be needed to the Harbour as work will be continuing there throughout the winter. Access to Seaview would be down the track to the Dunure Inn Car Park, which will be improved. At the moment they are in negotiations with South Ayrshire Council re purchase of ground at Seaview for this pumping station. It was suggested an open meeting should be held as members of the Harbour Committee feel they should be put in picture. An afternoon (2pm - 7pm) was suggested and Mr Findlay will put up posters. Secretary gave details of Kennedy Hall & Park Committee Secretary in order that the hall may be booked.

2. **Adoption of minutes for meeting of 16 October 2007.**

3. **POLICE REPORT:** P C Hamil gave his report as follows: During September/October there had been theft of a radio from a car in Fisherton Avenue. He also stressed everyone should be extra vigilant at this time of the year regarding bogus callers, and to pay extra attention to securing property.

4. **MATTERS ARISING:**

**Flashing Lights at school:** There is nothing further to report on this.

**Civic Pride:** Funding for speed bumps for park and three tables for Kennedy Hall will be asked for. The Christmas tree project will need more consideration. Getting lights to the proposed trees will cost quite a bit of money but this project may be able to go forward next year. Roy suggested repairs to the coping on the wall above the harbour. Mr Findlay suggests he could do this himself.

**Wind Farm:** Mr Montgomerie attended a meeting on 13 November and reported that all North Carrick Community Councils will be represented and he agreed that everyone should share the benefits from these wind farms. Two members are required from each Community Council involved, and funding will be available for running costs of this group.

5. **COUNCILLORS' REPORT:** I thanked Mairi Low for arranging poppy wreath, and also for obtaining extra copies of "Ayr Renaissance". Councillor Low had also obtained a copy of the minutes from Carrick Community Councils' Forum for our information. This unfortunately clashes with our own meetings.

Councillor Goldie is still concerned with lack of public conveniences and Council are looking into ways of making these available over a longer period, and finding the money to support this. She did confirm the toilets in Dunure had a very good reputation. It was mentioned to Councillor

Goldie that the new road surface (Station Road) had still not been white lined and she will make enquiries about this and also the flashing lights (north of school).
