1. **APOLOGIES:** Mr John Eaglesham, P C John Hamil, Councillors Mairi Low, Brian Connelly, Ann Galbraith.
2. **Adoption of minutes for meeting of 16 October 2007.**
Proposed by Mrs Margaret Masterman, Seconded Mr Adam Montgomerie.
3. **POLICE REPORT:** P C Hamil telephoned his report as follows: There has been an incident of drug misuse in the village, and a report has been sent to the Procurator Fiscal in connection with this. One reported vandalism to a car in Arran View. P C Hamil reminds everyone to be aware of cold callers and suspect emails.
4. **COUNCILLOR'S REPORT:** Councillor Goldie commented on the fact that South Ayrshire Council may find it necessary to make cuts across the board in the coming financial year. The lines in the bus turning area have still to be attended to and it will probably be in the form of designated parking bays to allow safe turning of the services buses. Mr Blair Wyllie is in the process of costing new flashing lights for north of Fisherton School. Councillor Goldie was advised of the problem of water on the road on Lagg Brae during excessive rain, which was dangerous during icy weather.
5. **MATTERS ARISING:**
Flashing Lights at school: See above
Civic Pride: Application forms have been sent in for speed bumps and signs for them for the park and three tables for hall. An acknowledgement has been received. As there is a balance to be used Mr Findlay suggested water cooler or coffee maker for hall. This will need to be discussed with Kennedy Hall & Park Committee. Making paths to the shore was felt to be too expensive and once the paths were made up they would have to be maintained. Also suggested by Mr Storie was to use this money or part of it to clean the graffiti from the castle and he will look into getting estimates. Another idea was for the laying of some paving slabs where the bench will eventually go. Mr Findlay will give us a price. We only have to the end of March to submit applications.
Web Site: Mr Macleod is in the process of getting this transferred and will update us at the next meeting.
Pumping Station: Harbour View will not be closed during construction of this and work should commence late January.
