ANNUAL GENERAL MEETING HELD ON TUESDAY 20 MAY 2008 IN KENNEDY HALL, DUNURE, AT 7.30PM

1. **APOLOGIES:** Mrs Margaret Masterman.
2. **Adoption of minutes for meeting of 15 April 2008.**
Proposed by Mr D Broadhead, Seconded Mr A Guthrie..
3. **POLICE REPORT:** During April/May, one person was reported for disorder. There was vandalism to cars on Station Road, also theft from a car. P C Hamil stresses everyone should be on their guard against bogus workmen, especially "gardeners" at this time of year.
4. **COUNCILLOR'S REPORT:** Councillor Goldie had clarified with Scottish Water and South Ayrshire Council re the repairs to the lane down to the Dunure Inn Car Park. It was confirmed that this was only to be done if Harbour View was completely closed during the work at the Pumping Station when in fact the work was completed without this necessity. Secretary advised that the ditch opposite the Water treatment Works in Station Road was actually damaged by a bus, however, the members suggest this area should be properly repaired and asked Councillor Goldie to pass on our thoughts here. Mr Eaglesham is concerned about the lack of bins in the lay-bys on the way out of the village and the top road. Mr Findlay considers the blue bins issued are too light, and have a habit of overturning in strong winds
5. **CHAIRMAN'S REPORT:** Mr Montgomerie said in his report that the two main concerns during the last year have been the completion of the Water Treatment Works, and currently the Pumping Station at Seaview, also the proposed Wind Farm at Knoweside.
The Pumping Station is nearing completion and while the site was not ideal, the finished result seems satisfactory and better than originally hoped for. This is scheduled to be finished at the end of May. The Wind Farm is ongoing and neither Knoweside nor Darsalloch is yet in to planning. Mr Montgomerie is on a "Wind Farm" Committee and it is hoped that after completion of these there will be a considerable financial benefit to the village and also surrounding areas of North Carrick.
Dr Begg has confirmed that the Coastal Path is now up and running and a formal opening is taking place on 28 June. In some areas the signs are not too clear but this will be checked out. Also it is unfortunate that at some points the walk is on the foreshore and high tide may be a problem. A book has been published about the path and is available in shops in Ayr.
Mr Montgomerie took the opportunity to thank all members for regular attendance and good input to our community Council. Thanks to new member Angus Macleod who has taken over the Web Site, thanks to Treasurer Roy, and also thanks to Secretary Jean McGinn.

Mr Storie gave a vote of thanks to the Chair.
